



# Terms and Conditions

## Terms and Conditions:

1. The Primary category forms part of the Childnet Film Competition 2018, organised by Childnet International.
2. Only students aged between 7-11 (by the time of the closing date) are allowed to enter the Primary age category of the competition.
3. The Childnet Film Competition is open to schools and youth organisations **within the UK only**. We welcome the creation of films from countries outside the UK but please note that these cannot be considered for the competition but may still be featured on the Childnet website and EC Safer Internet Centre networks.
4. Teachers must register and sign the entry form on behalf of students. Only entrants registered and entered with the signed entry form by their teacher or youth leader will be considered for the competition. The named registrar will be responsible for chaperoning, or for arranging another school representative, to chaperone their students to the finalist event in London if they are selected as a finalist. We can accommodate two chaperone's per team.
5. All films must be returned with both the completed media consent and signed entry forms by **5pm on Monday 11th June 2018**. Films received after this date cannot be considered for the competition but may still be featured on the Childnet website and EC Safer Internet Centre networks.
6. The winning films in this category will feature on the Childnet website and shared via Childnet's social media and EC Safer Internet Centre networks.
7. Each group must be made up of at least **2 people and no more than 8**. If successful, only the 8 listed on the entry form for the film they have entered can be invited to the finalist screening. (Please note if more people feature in the actual film, they cannot be invited to the finalist event).
8. Schools or youth organisations **can enter more than one film**. Please note that if one of the films entered is successful and makes it through to the finalist's event, only the young people involved in the making of that particular film can be invited to attend.
9. In the interests of running the Childnet Film Competition as a fair competition, we will only consider entries produced in collaboration between young people and their school/youth setting in a joint creative effort to create films that could also be used to educate young people about online safety.
10. All films must be **no longer than 1 minute**. **This time frame must include title sequences and credits should you decide to use these**. If adding credits, keep these brief to avoid cutting into your film time.
11. In the interests of child protection, credits added to the end of any film should **contain first names only**, in accordance with Childnet's media consent policy. Any films that contain full names of children and the name of the school or youth setting in the credits cannot be considered for the competition.
12. All films **must feature a positive message** and contain appropriate content and imagery.
13. All films must reflect the theme of the category.
14. The emphasis of the competition is on the message that you share, rather than a professional standard of recording. However, we ask you to submit films of a high enough standard comparable to other resources that would use to educate your own students.

15. All filming and production must be the work of the young people with no involvement from industry professionals. Teachers are expected to support and oversee the work of the project but not to be creating content themselves.
16. All films must respect copyright law. We prefer original music and video content. If you wish to use others' copyrighted material (e.g. music) you must obtain written permission from the copyright holder prior to the submission of your film and include this information with your entry.
17. To ensure content and copyright terms are adhered to before entering the Childnet Film Competition, **all films must be overseen by the teacher or youth leader.**
18. Prizes are intended as a school prize and not for individuals. Childnet reserves the right to change the prizes from those advertised for those of an equivalent monetary value.
19. Successful finalists will be notified on **Monday 18th June 2018.**
20. If you are selected as one of our finalists, you will be required to travel to London for the screening event on **Tuesday 3rd July 2017.**
21. Childnet will organise travel by public transport to the Film Competition event. In circumstances where a school opts to organise the travel arrangements themselves, we will reimburse after the event upon receipt of valid invoices/receipts, up to the limit of the cost of the travel we would have arranged by public transport.
22. Successful schools attending the finalists' screening event are allowed up to two chaperones. **These must be teachers or youth leaders.**
23. Please inform Childnet prior to the screening event should your school have any SEN requirements in order for us to make it the most enjoyable day possible for your students.
