

Terms and Conditions

Solo and Group Categories



1. The Solo and Group Categories form part of the Childnet Film Competition 2020, organised by Childnet International.
2. The Solo Category is for young people aged 7-18 and the Group Category is for young people aged 3-18. (The Group Category can include parents/carers or educators within the film).
3. The Childnet Film Competition is open to all young people **within the UK only**. We welcome the creation of films from countries outside the UK but please note that these cannot be considered for the competition but may still be featured on the Childnet website and EC Safer Internet Centre networks.
4. Educators/youth group leaders or parents/carers must sign the entry form on behalf of entrants. Only entrants entered with the signed entry form will be considered for the competition. The named adult will be the main point of contact.
5. **All films must be returned with both the completed media consent and signed entry forms by 5pm on Monday 22nd June 2020.** Only films submitted with signed consent forms from all participants can be entered into the competition. Films received after this date cannot be considered for the competition but may still be featured on the Childnet website and European Commission Safer Internet Centre networks. 6. The winning films in these categories will feature on the Childnet website and be shared via Childnet's social media and European Commission Safer Internet Centre networks.
7. If you are entering the Group Category, **each group must be between 2 - 8 people**. This is to include those who do not appear on camera but are working behind the scenes (e.g camera operator, director, etc.).
8. Individuals entering the Solo Category **can submit one film**.
9. Schools or youth groups **can enter more than one film**. Other groups, e.g sibling or family **can enter one film**.
10. All films must be **no longer than 2 minutes. This time frame must include title sequences and credits should you decide to use these**. If adding credits, keep these brief to avoid cutting into your film time.
11. In the interests of child protection, credits added to the end of any film should contain **first names only**, in accordance with Childnet's media consent policy. Any films that contain full names in the credits cannot be considered for the competition. For more information on how we handle data, please refer to **Childnet's privacy policy**.
12. All films **must feature a positive message** and contain appropriate content and imagery.
13. All films must reflect the theme of the category.
14. The emphasis of the competition is on the message that you share, rather than a professional standard of recording. However, we ask you to submit films of a high enough standard comparable to other resources that would be used to educate young people.
15. To maximise the learning element of the project, we encourage that all filming and production should be the work of the young person/people taking part.
16. All films must respect copyright law. We prefer original music and video content. If you wish to use others' copyrighted material (e.g. music, imagery or footage) you must obtain written permission from the copyright holder prior to the submission of your film and include this information with your entry.
17. To ensure content and copyright terms are adhered to before entering the Childnet Film Competition, **all films must be overseen by the named adult on the entry form**.
18. **Please note**, prizes are intended as a school/youth group prize. Please select your nominated school or youth group on your entry form. Childnet reserves the right to change the prizes from those advertised for those of an equivalent monetary value.
19. Winners of all categories will be announced on **Friday 3rd July 2020**.
