

# Frequently Asked Questions

## Solo Category



### ★ What is the Solo Category?

The solo category is for young people aged 7-18 who wish to submit individual entries. We will select 3 finalists from both primary and secondary entries.

### ★ When do I have to get the film back to Childnet?

The cut off for entrants is **17:00 GMT on Monday 22nd June 2020**. We will not be able to enter any film that arrives after this date.

### ★ When will I find out if I've won?

Winners will be announced on **Friday 3rd July 2020**.

### ★ How long must the film be?

All film entries must be 2 minutes or under. This time frame must include any credits you wish to add. It is advisable to keep credits to a minimum to avoid losing time for your film content and remember to add first names only!

### ★ How many films can I enter?

Entrants into the Solo category can enter **one film**.

### ★ What equipment should I use?

Everyone has different facilities and access to equipment. You could use anything from a camcorder to a mobile phone. It's the fantastic content that we will be looking for!

### ★ How do I send you my film?

Completed films and forms must be sent electronically (e.g. Dropbox or WeTransfer) to [film@childnet.com](mailto:film@childnet.com). **Remember the cut off is 5pm on Monday 22nd June 2020.**

**REMEMBER:** Ask your parent/carer, teacher or youth leader to help you make sure that your film meets the terms and conditions of the competition. They are also responsible for entering your film into the competition.

**Do make sure that you include your entry form and media consent form for everyone who appears in the film (you'll find these in your competition pack).**

### ★ What about adding music?

We can only accept films that contain original or royalty free music. Make sure that you have read our section on copyright before you include any music in your film.

### ★ What about adding images from an online game?

Unfortunately this will breach copyright so avoid using any images or footage of an online game as we won't be able to enter your film into the competition.

### ★ Are there any film-making resources I could use?

### ★ What is Childnet's GDPR policy?
